## Eligibility Requirements

The VA has established guidelines for honorably discharged Veterans and their surviving spouses applying for the Pension with Aid & Attendance benefit.

- ✓ 90 days or more of active duty, with at least one day of service during a wartime period
- ✓ Must have a medical condition which requires assistance with activities of daily living that is not related to military service
- ✓ Meet income-to-medical expense ratio
- ✓ Must meet asset requirement
